## General requirements

- 1. Before carry-out welding works this certificate either as certified copy or photo copy shall be submitted to the competent authorities issuing the building permit.
- 2. For advertising or other purposes this certificate may only be duplicated or published in full. The wording of the advertising material shall not be in contradiction to this certificate.
- 3. If the welding coordinator(s) mentioned in the certificate is (are) not longer with the company or if there are changes in the welding process or in essential parts of the facilities necessary for the welding works, the certification body has to be informed. If considered necessary a new plant inspection of the company will take place.
- 4. In case of doubt regarding the qualification of the company, an inspection and check-ups in the plant by the certification body without prior announcement are being reserved.
- 5. This certificate may be withdrawn at any time and with immediate effect without compensation supplement or modified if the condition under which this certificate has been issued have changed or if the requirements laid down in this certificate have not been adhered to.
- 6. At least two months before expiry, a new application has to be submitted to the certification body if the qualification should be certified once more.
